Approval of NMSA-Charter School Agenda

Governing Council & Board of Directors Chair Section

Catherine Oppenheimer welcomed new NMSA-Art Institute Board Member Nick Franklin and new Governing Council member Paula Tackett.

All meeting participants briefly introduced themselves.

Riis shared admissions information with all present.

ACTION ITEMS

Catherine Oppenheimer introduced Doddie Espinosa. Ms. Espinosa is a former dancer, has experience with the NDI in-school programs, and is a public school administrator. Catherine recommended Doddie become a member of the NMSA Governing Council.

- **Paula Tackett made a motion to approve Doddie Espinosa as a Governing Council Member. Sherry Thompson seconded the motion. Motion passed with a 3-0 unanimous vote.**

Catherine Oppenheimer made a recommendation to have Vickie Sewing (who was not in attendance) serve as Secretary of the Governing Council

- **Sherry Thompson made a motion to approve Vickie Sewing as Governing Council Secretary. Paula Tackett seconded the motion. Motion passed with a 4-0 vote.**

Cindy Montoya recommended that the Council approve the changes to the Council Membership: JD Bullington no longer being a Council Member and Doddie Espinosa as a new member.

- **Paula Tackett made a motion to approve NMSA-Charter School Governing Council changes.**
- **Sherry Thompson seconded the motion. Motion passed with a 4-0 unanimous vote.**

Charter School Principal Section

Cindy Montoya acknowledged effective collaboration between the Art Institute and the Charter. She recognized the contributions of Riis Gonzales, Julie Gomes, Natalia Chavez and Katy Phebus.

- Ninth grade academy has been a great success as indicated by the number of students who are having success in the classroom. Teachers are focusing on the soft skills that students need to achieve to be successful in school. Lisa Oberteuffer and Eric Crites are the instructors in this class.
- In January, Senior Seminar, Math Lab, and two teacher assignments will change to better support those students who are struggling in reading and writing.
- Dr. Mary McLeod has been hired as Assistant Principal in charge of instruction.
- NMSA Charter Renewal Process and Timeline Update: In October 2013, NMSA must submit a Charter application for renewal. An A or B grading for the current school year will be crucial. On December 14, 2013 PED will let us know if they have accepted our Charter. We will make every effort to have everything complete early.

Business Manager Section

- Christina Yamashiro reported that the Charter School Charter School is doing fine financially. Even with the recent hire of Dr. Mary McLeod as Assistant Principal.
- There are no BARS needing approval.


