- Stimulus Funds: JD Bullington reported to the Board that the Budget Adjustment Request has been approved by PED and that it currently sits in the Department of Finance. JD has spoken with Don Moya, Chief Financial Officer, who informed him that the stimulus monies are held up in the Department of Financial Administration. He will being speaking with Mr. Moya again today and attempt to clear this up prior to the Legislature Special Session scheduled to begin Saturday, October 17, 2009.
- JD recommended putting together a legislative packet for the special session to help aid in a favorable decision for the stimulus monies going to NMSA. The legislative packet should include bios, what the school is about, information on the admission process which is underway, facility negotiations, dormitory update and list of accomplishments.
- Discussions held with the Board re: strategy to secure stimulus funds.
- Catherine Oppenheimer made a Motion, JD Bullington seconded, to approve the deliverables of Jim Ledyard, the educational consultant as follow:

August deliverable—The Board approves this deliverable at the meeting today.

September – Sherry, Tom and Catherine to do audition schedule. They are authorized to review and approve payment of the September deliverable upon review of the audition schedule.

October – Payment of this deliverable will be upon presentation of the Audition plan to the full Board at the October board meeting. In the future, the deliverable will be considered to be a presentation of the described document in draft sent the full board for discussion at a board meeting.
